


Preserving and Expanding CDFI Minority Depository Institutions

Tips for Social Impact Data Collection

- **Think comprehensively**
 - If your bank has a strong commitment to serving churches, schools, health care centers, small businesses, etc. – this could all be of interest to investors. Devise metrics to track and capture this impact.
- **Define your metrics – and be consistent**
 - While many output metrics have standard definitions (\$ or # of loans by loan type), many outcome metrics do not (jobs created, affordable housing developed). Create definitions for your metrics that make sense for your bank – and stick to those metrics. Ensure all staff members are aware of the definitions and apply them consistently.
- **Distinction between what you can “take credit for” vs. what you “contribute to”**
 - Example: If over a ten year period, the value of the housing market in your target market increases, it would be difficult to “take credit” for this. But, a CDFI MDI can certainly take credit for the housing units it has developed, rehabilitated, or preserved and claim contribution to the increasing stability and value of that market (i.e. because those are correlated).
- **If you don’t have a lot of capacity currently – start with what you have and build from there**
 - If you don’t have the time, energy, staff capacity, or financial resources to undergo an extensive planning process, start with what you already collect and think about how to make the system more efficient. Then consider adding metrics over time. This can be a phased process focused on a small, core set of indicators to start and then transition to more robust data collection and reporting over time.




